### INFORMATION WE MAY COLLECT FROM YOU

Omerta may process personal data about you, because you use the services of Omerta. and / or because you provide Omerta with it. Omerta can process the following personal data:

- Your phone number
- Your email address
- Your IP adres
- Your browser information
- Your Facebook account ID

Information that you provide by filling in forms on our site(s) [barafranca.com](http://barafranca.com), [barafranca.nl](http://barafranca.nl), [omerta.pt](http://omerta.pt), [omerta.com.tr](http://omerta.com.tr), [omerta.wiki](http://omerta.wiki), and other sites of Omerta Publishing Limited. This includes information provided at the time of registering to use our site, subscribing to our service, posting material, requesting further services or by connecting our IRC server. We may also ask you for information when you enter a competition or promotion sponsored by our business partners and when you report a problem with our site.

If you contact us, we may keep a record of that correspondence.

We may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.

Details of transactions you carry out through our site and of the fulfillment of your orders. Details of your visits to our site including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

For some activities, we may ask you to create a username and password and/or to provide other, non-personal information such as your age, date of birth, gender, and/or game and platform preferences; and, combine such information with your personal information. In addition, your web browser may transmit certain geographic information or information regarding your computer (capabilities, game data processing, etc.) to Omerta Publishing Limited. We may use this information to generate aggregate statistics about our user community and may provide such non-personal information to advertisers and/or our partners. In addition, Omerta Publishing Limited may use such information for security, system integrity (the prevention of hacking, cheats, etc.), or enforcement purposes.

### IP ADDRESSES AND COOKIES

We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration and to report aggregate information to our partners. This is statistical data about our users' browsing actions and patterns, and does not identify any individual. For the same reason, we may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. Cookies contain information that is transferred to your computer's hard drive. They help us to improve our site and to deliver a better and more personalized service. They enable us:

- To estimate our audience size and usage pattern.
- To store information about your preferences, and so allow us to customize our site according to your individual interests.
- To speed up your searches.
- To recognize you when you return to our site.

You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies. However, if you select this setting you may be unable to access certain parts of our site. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you log on to our site.

### OMERTA SMS

Inside Omerta you have the option to register your phone number, if you do this you can receive messages from other players if you enable this option. It's also possible to get fully automatic messages from Omerta Publishing Ltd. about account related events.

Your phone number won't be visible to anyone and Omerta won't never share or use your phone number for other purposes.

## GOOGLE ANALYTICS

Omerta Publishing Ltd. uses Google Analytics. The information thus obtained is transferred to and stored by Google on servers in the United States. Read Google's privacy policy for more information. You also find the privacy policy of Google Analytics here. Google uses this information to keep track of how our website is used, in order to provide reports on the Website to Omerta Publishing Ltd. Google may provide this information to third parties if Google is legally obliged to do so. Omerta Publishing Ltd. has no influence on this. Omerta Publishing Ltd. has not authorized Google to use Analytics information obtained through Omerta Publishing Ltd. for other Google services.

## IRC

The basic IRC services that we offer don't require you to provide us with personally identifiable information as a condition of use.

If you register your nickname, you will be required to provide an email address which will only be used in verifying you are not a bot.

Our servers do collect routine internet connection information such as your IP address, the time of your connection. We also scan your computer for open proxies which could cause harm to the network. However, this type of information cannot be matched with any personally identifiable information about you since we don't collect it in the first place.

## WHERE WE STORE YOUR PERSONAL DATA

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff maybe engaged in, among other things, the fulfillment of your order, the processing of your payment details and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy. All information you provide to us is stored on our secure servers. Any payment transactions will be encrypted using SSL technology. Where we have given you (or where you have chosen) a password which enables you to access certain parts of our site, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorized access.

## USES MADE OF THE INFORMATION

We use information held about you in the following ways:

We may disclose your personal information to any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries.

We may disclose your personal information to third parties:

In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets.

If Omerta Publishing Limited. or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.

If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use and other agreements; or to protect the rights, property, or safety of Omerta Publishing Limited., our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.
